

## **Important Changes to Registration Fees 2012**

### **1.0 Proposed Dates**

Proposed registration dates for the 2012 season are as follows:

- Saturday 4th February 2012 10am til 2pm
- Wednesday 8th February 2012 4.30pm - 7pm
- Saturday 11th February 2012 10am til 2pm
- Wednesday 15th February 2012 4.30pm - 7pm

*Registrations will close 29th February 2012 at 7pm.*

### **2.0 Late registrations**

Registrations after the 29th February 2012 will only be accepted if there is a team in that age/grade with a vacancy.

### **3.0 Fees**

- All players' fees must be paid in full by the 29th February 2012.
- Players will be allocated to teams on a "first in" basis and only if fees have been paid in full.
- Players who are not financial will not be allocated to teams until all outstanding fees have been paid. Unfinancial players are not permitted to participate in trial games.
- Teams with insufficient financial players will not be nominated for the 2012 CCF competition.
- Fees are determined by Central Coast Football and will be advised in January 2012. Details will be made available on the website.

### **4.0 Extension of time to pay fees**

In cases of genuine financial hardship, the committee may approve an extension of time to meet fee commitments. If a player wishes to extend repayment beyond the 29th February 2012, then a written request, outlining the circumstances, is to be submitted to the executive committee for consideration by 29<sup>th</sup> February 2012. The executive committee will consider all requests by the end of March 2012.
