2020 Winter Season Registration and Competition

Dear Central Coast Football players and participants,

Obviously, the 2020 Season is being impacted by the current COVID-19 pandemic. As a result, we must make some changes for this year based on the information we have available.

Following the survey that we conducted last week, the majority of our players wanted to wait as long as possible to see if we can get some football played while some people want to de-register now and seek a refund.

Based on the feedback we have come up with a model that we believe offers solutions to our players while still allowing us to plan for Football later in the year.

Before going into the solution, it is important to note that we have received agreement from Central Coast Council that the winter season can now run until 25th October 2020 and the summer sports will start after that date. At this point, we are making plans for a season to start on 1 July 2020 and conclude at the end of October. Obviously, this is subject to change due to the evolving nature of the restrictions placed on community sport as a result of the Pandemic.

So, for 2020 we are offering our players two options which are outlined below:

Option 1. – Remain registered and we will protect the value of your registration.

With this option you will remain registered for the 2020 Winter Season and if, at the end of the season, we are unable to provide any football games we will provide the option of a refund or credit towards next year's registration equivalent to 100% of the amount you have paid to your club for 2020. If the season was to go ahead and the scheduled number of games is reduced to anything less than 14, we will provide you with a refund or credit of the proportional value.

Example: If only 11 games are scheduled, then the player would lose 3 games worth of value so would be provided with a credit of 3/14 of the amount, they paid towards their registration fee in 2020 in the form of a refund or credit towards 2021.

Should player's that are registered wish to take up this option, they do not need to do anything at this point.

Option 2. - De-register and Refund

We will open a de-registration window from April 9th until 5pm on April 24th. Anyone who wishes to de-register now and receive a full refund of any money they have paid to their club can do so by completing the form available on our website or Facebook post and they will receive a full refund of the amount paid to your club on or before May 1st. Players who take up this option will **NOT** be able to re-register for the 2020 Winter season due to start in July.

Under this option if you utilised an Active Kids Voucher during registration it would not be redeemable for cash and therefore would be forfeited.


